John Law of Acton, Massachusetts, and Reuben Law of Acton, Massachusetts, and Sharon, New Hampshire

JOHN¹ LAW may have arrived in the colonies as a Scottish prisoner of war.^[2] The Scots fought Cromwell at Dunbar on 3 September 1650 and a year later at Worcester. The results of both battles were similar – the Scots were decimated. Prisoners from the Battle at Dunbar arrived in Boston on the *Unity*^[3] December 1650, and from the Battle of Worcester later on the *John and Sara*. No passenger list exists for the *Unity*^[4] but a partial one exists for the *John and Sara*.^[5] John Law or any name that might remotely be considered Law (e.g., Lawson, Lawrence) does not appear on the *John and Sara*'s list.^[6]

In 1655 Concord was granted 2,000 acres for public grazing. The land west of Concord Center was referred to as New Grant or Concord Village. John Law settled there soon after. New Grant was eventually incorporated as Acton in 1735. While John Law may have been Acton's first settler, John Shepard, who received a grant in 1661, is the first documented settler there. John Law built his shelter on what is now known as Laws Brook Road in Acton near its intersection with School Street. John Shepard settled just to the north. For the ensuing forty years, controversy surrounded John Law's claim to his land. Houghton says, "we know he was stubborn, proud and held himself aloof from outsiders, but he was brave, hard working, and

devoted to his family."[11] Like his father, John's son Stephen had disagreements with the Concord selectmen who called the proprietors together "to decide what to do about Jno. Law & his son Stephen who do neglect & refuse to agree and hire land & meadow that they do now improve in ye village." From the 3 September 1700 meeting:

To empower the selectmen to use such methods with Stephen Law as may effect some absolute conclusion as to his eregular improvements of ye premises. Also voted to empower selectmen to set bounds to lands which Jno. Law doth improve to prevent him from encroaching fa[r]ther upon the Townes New Grant.^[12]

John's will dated 13 December 1707 was dictated to Samuel Buttrick and signed with a flourish. While he referred to "my beloved wife" and the children's "honored mother," he gave her no name. He gave sons Steven, Thomas, and Samuel land and moveables in the house, with Steven and Thomas caring for their mother. Daughter Mary was to have only "my great brass kettle" and to pay her sister Elizabeth twenty shillings as her share of the kettle. It was proved on 7 March 1707/8. [13]

JOHN¹ LAW was born in Scotland about 1635^[14] and died in Concord, Massachusetts, but surely in the southeast corner of what is now the town of Acton, on 4 January 1707/8. He married in Concord on 5 March 1659/60, LYDIA DRAPER, born in Concord on 11 November 1641, daughter of Roger Argument Mary (____) (Hadlock) Draper. She died in Concord on 6 January 1732/3 in her 94th [sic] year.

Children of John and Lydia (Draper) Law, born in Concord (now Acton):

- i. **JOHN² LAW**, born 7 March 1660/1;^[20] died Concord 26 Dec. 1690.^[21]
- ii. **THOMAS LAW**, born 10 Sept. 1663; [22] probably died young.
- iii. **STEPHEN LAW**, born 28 Aug. 1665;^[23] died Concord 25 Nov. 1733 in his 68th year,^[24] two years before Acton was made a separate town; married **DEBORAH** ____,^[25] and they had no children recorded in Concord. She is probably the "wid. Deborah" who died in Acton 11 Sept. 1754.^[26]

- iv. **ELIZABETH LAW**, born say 1678; died Simsbury, Conn., 13 May 1738;^[27] married (1) Concord 29 April 169_ [probably 1699], **JACOB READ**,^[28] born Concord 30 March 1673[/4?], son of Philip Read and Abigail (Rice) Law, [29] died Simsbury 3 Dec. 1709. [30] Elizabeth married (2) Simsbury in 1711 WILLIAM MOSES. [31]
- v. SAMUEL LAW, born 28 May 1680;^[32] died Groton, Conn., 29 or 30 April 1727;^[33] married Concord 15 March 1708, MARTHA (WIGGLESWORTH) WHEELER,^[34] born Malden, Mass., 21 Dec. 1683, [35] daughter of Reverend Michael and Martha (Mudge) Wigglesworth and widow of Dr. Joseph Wheeler, died Stonington, Conn., 4 Dec. 1719. [36] Samuel became a doctor, sold his house and moved to Groton, Connecticut. From the New England Weekly Journal: "Groton April 30. Last night Dr Samuel Law ... not being very well, made up two pills of physick, which he had just receiv's from Boston, for himself, and gave two of the same to a woman in the house... the woman waking before morning and finding herself very sick, went up to Dr Law and asked his advice what to do, but found him gasping for breath, and he dy's in a few minutes; and the woman her selfe is like to dye also."[37]
- 2. vi. THOMAS LAW, again, born probably in June 1682; [38] married SARAH
 - vii. MARY LAW, born say 1684; [39] married in Concord, probably in 1710, SAMUEL DAVIS. [40] probably born Concord 21 Jan. 1669[/70?], son of Samuel and Mary (Mead or Meadows) Davis. [41] and widower of Abigail (Read) Davis, sister of Mary's brother-in-law Jacob Read. [42]
- 2. THOMAS² LAW was born in Concord, probably in June 1682. According to Acton vital records, taken from his gravestone, Thomas Law died 16 April 1760 at age 77 years 10 months. [43] However, the age contradicts the birth date of the earlier Thomas Law as recorded in the Concord vital records by some twenty years. His stone in Woodlawn Cemetery in Acton is beside that of Susanah, his daughter, who preceded him in death. [44] Since the known son of John born in 1663 would have been well over 40 when he married, and since at least one of his siblings was born as late as 1680, it is reasonable to suppose that he was born in 1682. He

married about 1710 SARAH . [45] If she were age 43 when her last child was born in 1727, she would have been born about 1684, which agrees well with a husband born in 1682.

Thomas's father gave him a deed to some land on 4 March 1704 and by 5 May 1710 Thomas had built a house. On the latter date he mortgaged to Nathaniel Jones of Concord, taylor, for a

"valuable sum" two acres of meadow "on the Great Brook formerly called Laws Brook," ten acres of upland on which he had built the house and three square rods of land behind the house "that my father died possessed of." While the deed was not written as a mortgage, Nathaniel quitclaimed on the same lands back to Thomas "for divers good reasons" on 8 December 1723, which does imply that it was a mortgage. [46]

Two deeds suggest that Thomas owned rights to other lands. On 14 October 1719, he guitclaimed to Eleazer Brown on "my lot in Rutland," suggesting that there might be information about him in proprietors' of the Town of records Rutland, Massachusetts. For some reason Eleazer did not have Thomas acknowledge this until 8

April 1757. On 25 November 1729 he sold "a 61st right in Concord Village or New Grant" which had belonged to the place where [his grandfather] Roger Draper had lived. [48] Thomas's only other recorded sale is that for £300 to his son Titus on 2 April 1740, which reveals that he then owned 23 acres with the house, another 8 acres with a barn and 9 more, "chiefly medow ",[49]

[1717/8?], son of Jeremiah and Dorothy Wood, ^[54] died 28 April 1797 in his 81st year, buried Littleton. ^[55]

- 3. ii. JOHN LAW, born 15 Sept. 1714; [56] married SARAH BARKER.
 - iii. **TITUS LAW**, born 26 Oct. 1716;^[57] died in Acton 16 Feb. 1801 at age 84 [*sic*], buried in Woodlawn Cemetery;^[58] married ca. 1743 **MARGARET** ____,^[59] born ca. 1726, died 20 Nov. 1792 age 66, buried in Woodlawn Cemetery.^[60] In the 1744 Acton Church records: "It was the custom to labor at length with the erring and try to impress upon them the magnitude of their sins. Many times the effort was a success but now and again a recalcitrant sinner seemed bent on damnation. Such was the case of Titus Law who, remaining completely immovable after five years of exhortation was suspended and allowed to go his own way.^[61] On 8 Oct. 1745 Titus Law and Daniel Shepard divided a fence between them.^[62] Thus the Laws and Shepards were still neighbors. In 1774 Titus's dwelling was consumed in fire and he sought to have his taxes abated, which the town denied.^[63] On 15 May 1780 Titus refused to take the oath to be a surveyor for which he had been chosen on 6 March 1780.^[64]
 - iv. SARAH LAW, born 14 March 1719/20. [65]
 - v. Susanna Law, born 20 Oct. 1723; [66] died 14 May 1754 age "30 y. 5 m. 24 d.," [67] buried in Woodlawn Cemetery in Acton.
 - vi. STEPHEN LAW, born 8 July 1727;^[68] died 7 Nov. 1804 age 77, buried in Woodlawn Cemetery with Titus;^[69] married Boston 16 June 1768, REBECCA PRESCOTT,^[70] born ca. 1741, died Acton 31 Jan. 1809 age 68.^[71]

JOHN³ LAW, was born in Concord on 15 September 1714. He died before 18 February 1762.^[72] He married in Acton on 7 August 1737 **SARAH BARKER**, ^[73] born 4 December 1716, daughter of

John and Elizabeth (Harwood or Haywood) Barker.^[74] She may be the Sarah Barker who married, intentions filed at Acton on 1 November 1775, Jonathan Piper. [75]

"When the town of Acton was incorporated Titus Law (1735) was living on the road from mill corner, Stow, to Concord. On the same road, on part of the old homestead no doubt, were John. Stephen and Amos his brothers." [76]

A John Law was in service of the King in 1757^[77] and a John Law (often noted as his first born son) is said to have died in the French and Indian War in 1759. [78] However, it was not until 8 February 1762 that his widow Sarah declined to administer his estate and Joseph Barker was appointed. Sarah received a dower and the remainder of his estate was distributed to his eldest son John.^[79] The 1771 Actor valuation lists a John Law.^[80] So John Jr. did not die in 1759. But his father, John, died shortly after that war, apparently after a long illness, as the largest estate bill was paid to a Dr. Cummings. [81] The father John Law might have incurred injuries in the war.
